MOTION OF DEBTORS TO AUTHORIZE PAYMENT OF DEPOSITS AS ADEQUATE ASSURANCE OF PAYMENT FOR UTILITY SERVICES

NOW COME Oberweis Dairy, Inc., an Illinois corporation ("ODI"); The Oberweis Group, Inc., a Delaware corporation ("TOGI"); North Aurora Ice Cream, LLC, an Illinois limited liability company ("NAIC"); TOGI RE I, LLC, an Illinois limited liability company ("TRI"); Third Millennium Real Estate L.L.C., an Illinois limited liability company ("TMRE"); and TOGI Brands, LLC, an Illinois limited liability company ("Brands" and, together with ODI, TOGI, NAIC, TRI, and TMRE, the "Debtors"), as debtors and debtors in possession herein, by and through their undersigned counsel and, for their motion (the "Motion") for an order authorizing a procedure for paying deposits as adequate assurance of payment for utility services, pursuant to section 366 of the United States Bankruptcy Code, 11 U.S.C. § 101 et seq. (the "Bankruptcy Code"), respectfully state as follows:

I. <u>BACKGROUND</u>

1. On April 12, 2024 (the "**Petition Date**"), each of the Debtors filed a voluntary petition for relief under Chapter 11 of the Bankruptcy Code. Since the Petition Date, the Debtors

have remained in possession of their assets and have continued to operate their businesses under the jurisdiction of this court as debtors in possession in accordance with 11 U.S.C. §§ 1107 and 1108.

- 2. Neither a trustee nor a committee of unsecured creditors has been appointed in the Debtors' Chapter 11 Cases (the "Chapter 11 Cases"). Concurrently with the filing of this Motion, the Debtors have filed motions seeking joint administration of the Chapter 11 Cases; anticipating no objections to these motions, and in the interest of efficiency, this Motion has only been filed in the above-captioned proposed lead case, that of ODI.
- 3. The factual background relating to the commencement of the Chapter 11 Cases is set forth in the *Declaration of Adam Kraber in Support of Chapter 11 Petitions and First-Day Motions* filed on the Petition Date and incorporated herein by reference.
- 4. The Court has jurisdiction over this Motion pursuant to 28 U.S.C. §§ 157 and 1334. Venue lies properly in this Court pursuant to 28 U.S.C. §§ 1408 and 1409. This matter is a core proceeding pursuant to 28 U.S.C. § 157(b)(2)(A) and (M). The statutory predicate for the relief requested herein is section 366 of the Bankruptcy Code.
- 5. Collectively, the Debtors operate a business (the "ODI Business") that manufactures, packages, and distributes milk, ice cream, and other dairy and non-dairy foods (collectively, the "ODI Products"). The ODI Business consists of three distinct segments—"Oberweis Dairy" branded dairy store operations, grocery retail sales, and direct-to-doorstep home delivery. The branded dairy store operations consist of 40 owned and operated Oberweis dairy stores throughout four states in the Midwestern United States that serve the ODI Products. The grocery retail sales consist of the sale of the ODI Products to retailers or distributors in approximately 850 national grocery stores and regional supermarkets across seven states. The

direct-to-doorstep home delivery operations consist of the delivery of the ODI Products directly to consumers across five states.

- 6. In the ordinary course, the ODI Business uses water, electricity, gas, garbage removal, telephone, internet, and other services of the same general type or nature (each a "Utility Service," and together, the "Utility Services") provided by various utility companies and other providers (each a "Utility Company," and together, the "Utility Companies"), including the Utility Companies set forth in the lists attached hereto as Exhibit A and incorporated herein by reference, which provide service to the Debtors, as the case may be.²
- 7. Maintaining uninterrupted Utility Services is essential to the Debtors' continued operations of the ODI Business. The ODI Business' three separate operations have over 290 separate utility accounts from over 65 different Utility Companies. Should the Utility Companies refuse or discontinue service, even for a brief period, the ODI Business would be adversely impacted and the Debtors' efforts to sell the business as a going concern would be jeopardized. It is therefore critical that the Utility Services provided by the Utility Companies continue without interruption.

II. <u>RELIEF REQUESTED</u>

- 8. In accordance with 11 U.S.C. § 366, and based on the adequate assurance of future payment as further contemplated herein, the Debtors request that this Court enter an order:
 - a. Implementing procedures (in the form and manner hereinafter discussed) to provide adequate assurance of payment to the Utility Companies;
 - b. Deeming the cash deposit approximately equal to one-half (1/2) the average monthly invoice or bill the Debtors received from each Utility Company as calculated over a twelve (12) month period prior to the

Petition Date³ (each a "Utility Deposit," and together, the "Utility Deposits") to constitute adequate assurance of payment of the Utility Companies under 11 U.S.C. § 366(b) and (c); and

- c. Prohibiting the Utility Companies from altering, refusing to provide, or discontinuing the Utility Services, or discriminating against the Debtors solely on the basis of the commencement of the Chapter 11 Cases or on account of any unpaid invoice for services provided prior to the Petition Date, unless:
 - i. the Debtors fail to make their monthly payments for services utilized after the Petition Date;
 - ii. a Utility Company gives written notice of said failure to make the required payments to (i) to the Debtors, c/o Adam Kraber, 951 Ice Cream Dr, North Aurora, IL 60542, (ii) to the Debtors' counsel, Howard L. Adelman, Esq., Adelman & Gettleman, Ltd., 53 West Jackson Blvd., Suite 1050, Chicago, Illinois 60604, and (iii) counsel to the committee of general unsecured creditors, if appointed (the "Notice"); and
 - iii. the Debtors subsequently fail to cure said default within ten (10) business days of their receipt of the Notice; and
- d. Prohibiting a Utility Company from seeking additional Utility Deposits from the Debtors in the event such Utility Company applies a setoff of any prepetition deposit(s) against debts that arose from prepetition Utility Services, if any.
- 9. Section 366 of the Bankruptcy Code provides in relevant part:
- (a) Except as provided in subsections (b) and (c) of this section, a utility may not alter, refuse, or discontinue service to, or discriminate against, the trustee or the debtor solely on the basis of the commencement of a case under this title or that a debt owed by the debtor to such utility for service rendered before the order for relief was not paid when due.

. . .

(c)(2) Subject to paragraphs (3) and (4) [of subsection (c)], with respect to a case filed under chapter 11, a utility referred to in subsection (a) may alter, refuse, or discontinue utility service, if during the 30-day period beginning on the date of the filing of the petition, the utility does not receive from the debtor or the trustee

³ The Debtors have reduced an ongoing fine paid in conjunction with the invoice for service from Fox Metro Wastewater Reclamation District by \$30,000 on a go-forward basis. adequate assurance of payment for utility service that is satisfactory to the utility.

11 U.S.C. § 366.

- 10. Section 366 serves to protect a chapter 11 debtor against termination of its various utility services immediately upon the entry of an order for relief, while simultaneously providing utility companies with adequate assurance of future payment for postpetition services. *See* H.R. Rep. No. 95-595, at 350 (1977), *reprinted in* 1978 U.S.C.C.A.N. 6306.
- 11. The 2005 amendments to the Bankruptcy Code added a definition of "assurance of payment" as one of the following:
 - a. a cash deposit;
 - b. a letter of credit;
 - c. a certificate of deposit;
 - d. a surety bond;
 - e. a prepayment of utility consumption; or
 - f. another form of security that is mutually agreed upon between the utility and the debtor or the trustee.

11 U.S.C. § 366(c)(1)(A).

- In order to provide the Utility Companies with adequate assurance of payment for postpetition Utility Services, the Debtors propose to provide each Utility Company with the option to receive a Utility Deposit. Each of the 40 branded dairy stores has their own unique account with over 65 Utility Companies. As a result, the Debtors must, upon request, pay 295 Utility Deposits to provide adequate assurance of payment to the Utility Companies totaling \$116,619.21.
- However, upon termination of a Utility Service, the Debtors request the Court to require the Utility Company to apply the entire Utility Deposit to the final amount due for

postpetition service only before returning any excess amounts or sending a final bill if the deposit did not cover the total amount due.

- As of the Petition Date, certain of the Utility Companies may have had outstanding accounts receivable against the Debtors. The Utility Deposits, however, shall not be applied to any such prepetition debts. Pursuant to 11 U.S.C. §§ 362(a)(7) and 366(c)(4), the Utility Companies may only apply a setoff of any prepetition deposits against prepetition debts of the Debtors.
- The Debtors request that they be allowed ten (10) days from the date of receipt of a written request to make a Utility Deposit with the requesting Utility Company. In addition to the relief requested above, the Debtors further seek entry of an order by which the Utility Companies are deemed to have adequate assurance of payment under 11 U.S.C. § 366(b) and (c).
- The Debtors propose to serve via U.S. Mail any related order, once entered, upon all the Utility Companies.
- As the relief sought herein pertains to all of the Debtors' Utility Companies, the Debtors also seek this Court's authorization to supplement (as and if needed) the lists of Utility Companies on Exhibit A with any Utility Companies not currently scheduled but subsequently identified.
- The uninterrupted provision of the Utility Services is vital to the Debtors' operations and thus the success of the Chapter 11 Cases, and the Debtors therefore submit that the relief requested herein is in the best interests of their respective estates and creditors. The proposed method for furnishing assurance of payment for postpetition Utility Services through a deposit upon request is consistent with the protections and requirements of section 366 of the Bankruptcy Code, and is not prejudicial to any Utility Company.

ORDER GRANTING MOTION TO AUTHORIZE PAYMENT OF DEPOSITS AS ADEOUATE ASSURANCE OF PAYMENT FOR UTILITY SERVICES

THIS CAUSE coming to be heard on the motion of Oberweis Dairy, Inc.; The Oberweis Group, Inc.; North Aurora Ice Cream, LLC; TOGI RE I, LLC; Third Millennium Real Estate L.L.C.; and TOGI Brands, LLC (the "Debtors"), pursuant to 11 U.S.C. § 366, for an order authorizing the Debtors, upon request, to provide adequate assurance of payment for utility services in the form of the Utility Deposits (as defined below), and prohibiting the respective providers of such services to the Debtors (each a "Utility Company," and together, the "Utility Companies") from discontinuing service unless certain conditions are met (the "Motion"); the Court having reviewed the Motion and having determined that cause exists to grant the relief requested therein; and the Court having jurisdiction and the subject matter of the Motion;

NOW, THEREFORE, IT IS HEREBY ORDERED as follows:

- 1. The Motion is granted to the extent provided herein.
- Absent any further order of the Court to the contrary, each of the Utility Companies providing service to the Debtors, including but not limited to the list of Utility Companies set forth in Exhibit A attached hereto and made a part hereof, shall not alter, refuse, or discontinue service to, or discriminate against, the Debtors solely on the basis of the commencement of either or both of the chapter 11 cases or on account of any unpaid invoice for service provided prior to the petition date, unless:
- the Debtors fail to make their monthly payments for the applicable Utility Company's services utilized after the petition date (a "Default");
- the applicable Utility Company gives written notice of said Default (i) to the Debtors, c/o Adam Kraber, 951 Ice Cream Dr, North Aurora, IL 60542, (ii) to the Debtors' counsel, Howard L. Adelman, Esq., Adelman & Gettleman, Ltd., 53 West Jackson Blvd., Suite 1050, Chicago, Illinois 60604, and (iii) counsel to the committee of general unsecured creditors if appointed (the "Notice"); and
- the Debtors subsequently fail to cure said Default within ten business (10) days after receipt of the Notice.
- In the event of a Default, the applicable Utility Company may, without further action of the Court, alter, refuse, or discontinue service only in the event the Utility Company serves the Notice of the Default and the Debtors fail to timely cure thereafter.

- Subject to any order of this Court authorizing the Debtors' use of debtor-in-possession financing or cash collateral, the Debtors are hereby authorized, within ten (10) days of receipt of a request in writing by a Utility Company, to pay to each requesting Utility Company a cash deposit approximately equal to one-half (1/2) the average monthly invoice or bill the Debtor received from such Utility Company as calculated over a twelve (12) month period prior to the petition date (each a "Utility Deposit," and together, the "Utility Deposits"), as specifically set forth in Exhibit A hereto.
- Absent further notice, hearing and order of the Court in accordance with 11 U.S.C. § 366(c)(3) (A), each of the Debtors' Utility Deposits shall be deemed to constitute adequate assurance of payment under 11 U.S.C. § 366(b) and (c) with respect to the Utility Companies.
- In the event a Utility Company applies any prepetition utility deposit(s) to any amount(s) owed 6. by the Debtors as of the petition date, the Utility Company is hereby prohibited from seeking an additional Utility Deposit or further assurance of future payment.
- The Utility Companies are prohibited from applying the Utility Deposits or any portion thereof 7. to any amount(s) owed by the Debtors as of the petition date.
- Nothing contained in the Motion or this order shall be deemed to grant administrative-expense 8. priority treatment to any claim that may be asserted by or on behalf of any Utility Company for any amount that is not an actual and necessary cost or expense of preserving the applicable Debtor's estate.
- The Debtors shall serve a copy of this order via U.S. Mail upon each of the Utility Companies listed on Exhibit A hereto and file proof thereof with the Court.
- 10. If an additional Utility Company or account number not currently appearing on Exhibit A is identified by the Debtors, the Debtors shall file with the Court a supplement to Exhibit A adding the names of such additional Utility Company or account number, and upon serving a copy of this order upon such additional Utility Company, the terms of this order will be deemed to apply to such additional Utility Company or account number, unless modified by the Court after notice and a hearing.
- 11. Neither the inclusion of, nor the failure to specify, any Utility Company by name in the Motion or this order shall be deemed an admission by the Debtors that such entity is, or is not, as the case may be, a utility within the meaning of 11 U.S.C. § 366, and the Debtors shall be deemed to have reserved all of their rights with respect thereto.
- 12. Upon a Debtor's termination of a Utility Service, the Utility Company must apply the entire Utility Deposit to the final amount due for postpetition service only before returning any excess amounts to the Debtor or sending a final bill if the Utility Deposit did not cover the total amount due.
